## What are cookies?

Cookies are small text files that are stored on your device when you visit our website. These cookies help us improve your Browse experience, remember your preferences, personalize content, and analyze our traffic.

## Types of Cookies We Use

We classify our cookies into the following categories so you can easily understand their purpose:

- **Essential and Technical Cookies:** These are strictly necessary for the website to function. They enable navigation, security, and the use of basic functionalities. They cannot be disabled from our systems.
- **Functionality or Preference Cookies:** These allow the website to remember the choices you make (such as language or display settings) to provide enhanced and more personal features.
- **Performance or Analytics Cookies:** These help us understand how users interact with our website by collecting anonymous information about pages visited and time spent. We use this data to improve our service.
- **Advertising and Tracking Cookies:** These are used to track your activity across websites in order to build a profile of your interests and show you relevant ads. They are set by us or our advertising partners.

  - **Purpose:** Essential for technical operation. It maintains the user's session state active while Browse through pages.

  - **Purpose:** Stores your consent preferences regarding the use of cookies so that we do not ask you again on future visits.

  - **Purpose:** A technical cookie used to debug the implementation of the Meta Pixel. It is not used for user tracking.
